There are three ways to support us. Which is best for you?

MEMBER: A person or business paying annually or monthly receives these benefits:

- **A receipt showing your tax-deductible contribution** to a 501(c)3 educational nonprofit.
- A benefit credit will be issued to your account for purchase of tickets, films, and Gathering merchandise of your choice. Membership levels and benefit credits are:
 - Bronze Member - \$6 per month or \$60 annually (\$10 credit)
 - Silver Member - \$12 per month or \$120 annually (\$20 credit)
 - Gold Member - \$24 per month or \$240 annually (\$40 credit)
 - Supporting Member - \$50 per month or \$500 annually (\$75 credit)
 - Partner Member - \$100 per month or \$1000 annually (\$100 credit)
- Access to early sale of tickets.
- Name listed on website and in event program if active on Jan 27, 2022.
- Member level name badge (pick-up at event only).

SPONSOR: A business paying annually or monthly receives these benefits:

- **A receipt that is deductible as a business expense for advertising.**
- **A display ad in our Event Program** at ad rates below (ad copy due by Jan 27, 2022), plus free tickets to Thursday night's Welcome Party for performers at the Holland Hotel:
